MONDAY, OCTOBER 4 - Come join us as we travel over the Sierra Nevada Mountains to the eastern slope and the town of MAMMOTH LAKES. Our first stop will be for a no host lunch in Gardnerville. Our accommodations for the next four nights will be at Shilo Inn and suites in Mammoth Lakes. Tonight we will have a hosted dinner at the Restaurant at Convict Lake.

TUESDAY, OCTOBER 5 - There will be a hosted continental breakfast at our hotel this morning before we begin exploring this beautiful area. Our step-on guide will inform us about the wonders of the area. Some of the interesting places on our agenda today will include Minaret Vista, Devil's Post Pile, and many of the lakes in the area. Along the way we will stop to have a hosted lunch at the famous Mammoth Mountain Inn.

WEDNESDAY, OCTOBER 6 - Start your day with a hosted continental breakfast before boarding our motorcoach to go the Mono Lake. Our step-on guide will inform us about Mono Lake's past, present and future. Our first stop will be at the South Tufa Towers where you will see first hand the wonders of Mono Lake. Then we will travel to the Visitor Center where we will see a movie and have time to explore the exhibits there. We will have a hosted lunch along the way. This afternoon we will visit the historic ghost town of Bodie. Here you'll see what's left of Bodie, an original ghost town from the late 1800's. Bodie stands today in a state of "arrested decay", so coined by the State of California when they took over the town in 1962 to make it a State Historic Park.

THURSDAY, OCTOBER 7 - After you partake of the hosted continental breakfast board our motorcoach to travel wherever our step-on guide decides to take us today. You know with all of the beauty in this area you will not be disappointed. Tonight a delicious hosted dinner will be served at Skadi's Restaurant.

FRIDAY, OCTOBER 8 - Our final day!! After a hosted breakfast at our hotel before we depart this interesting area. We will stop at High Hill Ranch for a hosted barbecue lunch. There will be time to browse in their arts and crafts area and shop in their store. Approximate arrival time home will be 6 pm.
